# **How does Automatic Routing work?**

We will schedule your deliveries for you. Our goal is to top off your tank when the gauge reads between 30-40%. Your driver will leave a copy of the fuel delivery tag for you, this serves as your bill. You have 30-days from the delivery date to pay your bill. Any account with an overdue balance (past 30 days) will not receive a delivery until the entire balance due is paid. \*Once the overdue balance is paid you will receive a delivery (if needed) the next delivery day for your area.

### How often will you be scheduled for a delivery?

The biggest factor affecting the frequency of your deliveries is the weather. Average winter usage will require a delivery every 4-6 weeks. As the weather warms your deliveries will be less frequent. If your propane usage changes you must let the office know so we can schedule your deliveries effectively. Some reasons propane usage can fluctuate are; burning more or less fire wood, extended period of time away from home, or an additional propane appliance such as a spa, generator, BBQ, etc.

# What if you run out of propane on the Automatic Route?

If you run out of propane and do not have an overdue balance, please give us a call. When the office is closed we have an on-call driver to deliver if your tank is empty. If your tank is not empty and you request an on-call delivery there is a \$95 service charge. \*After an over-due balance is paid, on-call service is not available to you before the next delivery day for your area.

We require your social security number on the credit application.

#### **Notes to Landlords:**

If your tenant moves out and owes money on their account, the landlord will be responsible for the balance due.
