### Quote & Equipment Purchase Agreement, 250 gallon Propane Tank

- REFURBISHED 250 gallon Propane Tank \$1,950

All of our equipment/tank purchases are for newly refurbished tanks, not brand-new equipment. Refurbished tanks include all new valves and gauges, and are freshly painted white.

The *price of the tank includes the setup*, (delivering, installing and safety checking of the system), if the tank location is easily accessible, otherwise, we bill the additional time required at our hourly labor rate of \$95/hour. The tank and parts are covered by a one year warranty from the date of purchase.

**All of our equipment purchases are *REQUIRED* to have the *first propane delivery to be completed by Signature Propane, at the time of the set, which is an additional charge.*** If the fill is unable to be completed at the time of the set (due to fuel transfer quantities), we will charge you for the gallons required to fill, on the work order, and apply the amount paid as a credit to your account. The propane pricing will be calculated at the current price per gallon, including qualifying discounts, the day the tank is set. There is a hazardous material fee of \$8.67, which will also be included in the fuel delivery. Please call us for our current pricing and available discounts.

If you would prefer to transfer fuel from your existing tank into your new/refurbished tank, we will complete up to 20% capacity of the fuel transfer at no charge. If you require additional fuel transfers, we can do so for \$95/hour, labor charge. We only transfer fuel from customer owned tanks or Signature Propane leased tanks. We do not transfer fuel from tanks leased by other propane companies.

**\*\*The parts listed above are suggested and are provided for information purposes only. When installing a customer owned tank, the parts required will vary and are dependent on your individual system requirements. We can provide a more detailed invoice, including all parts required for your tank set, after the purchase agreement is signed. We can also calculate the price of the required first fill, at the time of our agreement.**

Propane tanks and parts are taxable. Our labor rate and residential propane deliveries are non-taxed.

**All tank sales require a \$1,000 deposit.** If you wish to proceed, please sign and return this purchase agreement and include the deposit amount via check or money order, or call the office to pay by debit/credit card. *We must have access and availability to set the tank within three months of paying the deposit.* This equipment purchase agreement is valid for 30 days from the date the quote was provided and is valid only for the price of the tank. As previously mentioned, the price of the parts and the fuel delivery are varied.

\_\_\_\_\_ (Initial) the price of the propane tank is valid for 30 days

\_\_\_\_\_ (Initial) once this purchase agreement is signed; you have 90 days to grant us access to set the tank or the equipment agreement expires

\_\_\_\_\_ (Initial) the price and requirements of parts varies and is finalized on your final work order

\_\_\_\_\_ (Initial) the first propane fill is required to be completed, by Signature, at the current price per gallon, as part of this purchase agreement and is an additional charge

\_\_\_\_\_ (Initial) fuel transfers up to 20% are included in the purchase, additional fuel transfers are billable at our labor rate listed above

\_\_\_\_\_ (Initial) the deposit amount paid, can be refunded if we are unable to set the tank within the allotted timeframe

\_\_\_\_\_ (Initial) the balance of the propane tank, parts and fuel delivery, will become due the day the tank is set and filled, respectively
